# What is the 'Understanding Diverse Cultural Backgrounds and Ethnicity for Adult Social Care (DECK)' study about?

The purpose of this study is to better understand the influence of diverse cultural backgrounds and ethnicity as barriers to access and uptake of local authority commissioned adult social care services, in the London Boroughs of Newham and Redbridge.

It is a scoping study, that uses realist action research methods.

- Review the terms of reference for the Advisory Group, and sign up and work to these
- Maintain confidentiality where appropriate
- Meetings should be a safe space, where members feel like they can be transparent, open, and know that no-one intends to cause offence

#### Length of membership

Membership of the Advisory Group will be for 12 months in the first instance.

Membership is voluntary and members may withdraw from the role at any time; the study lead will be available to discuss any issues and look at ways of supporting continued involvement where possible if a member needs to withdraw.
